Sir,

As per reference section 2.2.5 of Operations Manual for STRIVE, approved on 3rd January 2019 by the National Steering Committee chaired by Secretary, Ministry of Skill Development and Entrepreneurship (MSDE), a National Cluster Evaluation Committee (NCEC) was constituted for selection of Industry Clusters (ICs) under Result Area 4, improved and Broadened Apprenticeship Training under STRIVE project.

2. The State Apprenticeship Advisors were requested to identify potential clusters in their states vide letter No. DGT – 1(27)/D1/SAMC/2017-AP dated 14.01.2019. Accordingly, Industry clusters were identified and mobilized by States and shortlisted through a competitive selection process by State Cluster Evaluation Committee (SCEC) followed by formal recommendation through their respective State Steering Committee (SSCs)

3. The first meeting of NCEC was convened on 01.03.2019 for evaluation and selection of ICs applications recommended by /states and 10 ICs were selected.

4. Second NCEC meeting was organized on 18th October 2019 to deliberate the drop out cases from the first selection.

5. The NCEC members discussed and deliberated the recommendations made by States concerned and agreed to recommend following Industry Clusters (ICs) :

6. The approval of these Industry Clusters mentioned in para 5 is based on condition to fulfilling following :

- Industry Cluster from Gujarat mentioned in the above table is based on condition to fulfilling recommendation through the respective States Steering Committee to DGT till 30th November 2019)
- Aluva Plastic Consortium is based on the condition to submitting an undertaking to DGT that the cluster/its members are currently not engaging and in future will also not engage in the production/manufacturing of single use plastic (soda/water bottles, plastic bag, straws coffee stirrers etc.)
- All Industry Clusters listed in para 5 are advised to partner with it is for implementing Dual System of Trailing(DST)

7. The States concerned are requested to communicate the selection to Industry cluster.
